In considering your application, we will search your record at credit reference agencies ("your records"). They will add to your records details of our search and your application and this will be seen by other organisations that make searches.

We will use a credit scoring or other automated decision making system when assessing your application. We will also add to your records details of your agreement with us, the payments you make under it, any default or failure to keep to its terms and any change of address you fail to tell us about where a payment is overdue. It is important that you give us accurate information. We will check your details with fraud prevention agencies and if you give us false or inaccurate information and we suspect fraud, we will record this.

Your records will be shared with other organisations and used by us and them to:

- Trace debtors, recover debt, prevent money laundering and fraud, and to manage our accounts
